#### 1. PRELIMINARIES:

### 2 APPOINTMENTS/HEARINGS:

2.1 BOH Vacancy Appointment

A MOTION was made by CN and 2<sup>nd</sup> by LJ to appoint Christopher Genoter to fill the remaining term left by the resignation of James Le'Cuyer to April 2020 in Townsend. Voting 2/0 MOTION passes. Welcome back Chris!

2.2 Gilchrist Road - Discussion on Housing

RM explained the Fire Department responded to a call on Gilchrist where a person had to be removed by the window to seek hospitalization. He further noted they filed an elder at risk and the nurse had been by at least a dozen times but was never let in. The remaining person in the home is just getting around to getting services with a nurse. Chairman LJ asked to have Town Council weigh in on the Board's obligation to respond to Fire Department reports. She requested herself, RM and CW get on the Town Council calendar for the last Tuesday of the month.

A MOTION was made by CN and 2<sup>nd</sup> by LJ to continue the hearing to the last meeting in August. Voting 2/0 MOTION passes.

### 2.3 33 Bailey Road - Septic Upgrade

The following variances were requested:

- a.) CMR 15.405(1)(h) reduction in the 4' separation required between the bottom of the soil absorption system and high groundwater. Requesting a 12" reduction resulting in sewage absorption system being 36" above high groundwater with a reported 5 min per inch perc rate.
- b.) CMR 15.405(1)(j) reduction in the 12" separation required between the inlet and outlet tees an high groundwater provided Is 9" to tank inlet 6" to tank outlet 5" to pump inlet and 4.5" to pump outlet. Note tank and pump have rubber boots at pipe penetrations.

A MOTION was made by CN and 2<sup>nd</sup> by LJ to approve the variances and Presby septic design upgrade for 33 Bailey Road. Voting 2/0 MOTION passes.

2.4 Update to Selectmen on residential and non-residential debris

CW explained the Highway Department will no longer be using the Recycling Center to dispose of debris and the Tree Warden is going to keep his area roped off so no one will be able to access the area but CW and the Tree Warden.


