MEETING MINUTES FOR MAY 24, 2018 7:30P.M. SELECTMEN'S CHAMBERS, TOWN HALL - 272 MAIN STREET, TOWNSEND, MA

- PRELIMINARIES VOTES MAY BE TAKEN: I.
- 1.1 SL called the meeting to order. Roll call vote showed 3 members present: Chairman Sue Lisio (SL), Vice-Chairman Cindy King (CK) and Clerk Wayne Miller (WM). 1.2

- 1.3 SL announced the meeting is being tape recorded. SL queried the audience members if anyone else would be taping.

- II. APPOINTMENTS AND HEARINGS - VOTES MAY BE TAKEN:

The Board met with Mr. Turgeon of the Ashby Townsend Baseball Association. The Board reviewed the memorandum submitted by Mr. Turgeon - (please see attached).

Dog issue - Mr. Kreidler read from the legal opinion into the record - (please see attached).

Mr. Turgeon stated the organization is interested in obtaining a license as outlined in Town Counsel's opinion. Mr. Turgeon has spoken with residents and changed the associations' requests. Mr. Turgeon read his memorandum into the record - (please see attached).

Mr. Craven inquired as to the removal of the trees and requested the town pay for the removal. Mr. Kreidler stated there would be a procurement process that would need to be done for the removal of the trees as it is town owned.

Three issues identified in the letter:

- 1. Dogs, clarification it is only in the fenced in area.
- 2. Tree Removal, TAYSA will pay for removal.
- 3. Willing to take full responsibility for all maintenance of the field and willing to schedule other events for residents with a signed agreement.

CK voiced concerned with the trees being a liability and issues with movie night being a different expectation than baseball games prior to evening.

Neighbors voiced concerned with trespassing issues, security and property damage along with concerns about removing trees. Additional issues voiced by residents included: playground, residents use, expectations, scheduling of events, parking area and space for such. WM voiced concern with parking lot and clear cutting of any trees while pointing out the town does not currently spend any money to maintain any of the fields. The Board discussed different options for issuing a license to TAYBA and a scheduling calendar online for residents to view.

SL would like Mr. Turgeon to work out the issues directly with the abutters/residents. SL stated she would agree limited license for one year until all the issues can be worked out.

Mr. Kreidler will draft a license agreement for the Board to review and to work with setting up a meeting with Mr. Hanks and Mr. Turgeon to review and tag trees.

As the League President of the Townsend Ashby Youth Baseball & Softball League (TAYBS), I want to thank you for providing this continued opportunity to speak with you on some items we would like the assistance of the town.

Since Mr. Craven gave the fields to the town in 1988 thousands of children have enjoyed playing on Craven Field with parents, family members and our community watching them. I know it was and remains his wish that the field be used for recreational purposes for our community members. TAYBS for the past 10 years has continued with that vision as had the Townsend Little League before it.

We have three issues we are asking of the town for assistance on:

- 1. As our town does not have a dog park, people look to find fenced in areas where they can let their dogs run free. Unfortunately, our ball fields are the only fenced in place in town that are the perfect size for people to use for their dogs. These dogs have caused significant damage to the fields themselves as well as use it as a public bathroom. We have put up several "no dogs allowed" signs, but to date this has not proved to be a successful deterrent. We have had people physically remove our signs and continue to use the field as a dog park and bathroom. It is important to note that we only want to keep the dogs off the fenced in field itself, and not the general property. We have no issues with people bringing their leashed dogs to games or using the other aspects of the property for recreational use.
- 2. The property has a significant number of very large trees on it. Because of these large trees, our field remains in the shade for a good portion of the day and as the sun goes behind the trees early in the evening causes visibility issues and our games tend to need to be called early for the safety of the kids. In addition to this, these are old trees, many of which continue to fall year after year. Our league willingly takes on the expensive burden of repairing the fences and field each year from the tree damage.
  - a. We have already received your permission to remove trees 20' from around the fenced in area, and we have been making progress with volunteers, but we are now to the point we need professional assistance to come in and clear the remaining trees out.


