Applicant: Locke Brooke Solar, LLC Location: 22 West Meadow Road

**Project:** The proposed project is for the development of a ground-mounted solar photovoltaic

energy system. Project is located within in the riverfront area, ACEC and ORW.

Applicant: Iodice Family Trust
Location: 59 West Meadow Road
Project: Wetland Delineation

Stan Dillis was present, representing the Iodice Family Trust. A wetland delineation was completed on the property. Richard Hanks (RH), Enforcement Officer, was present as a Cease and Desist was sent out for

gravel removal. RH would like to see the banks graded and the water table resolved. MT- would like to see areas of disturbance that are within the jurisdictional area restored. As there is more than an acre of disturbed land, a SWPPP and NPDES will most likely be needed. We would also like an independent monitor to ensure that the area is restored properly. A NOI will need to be filed.

### 3.0 Work Session:

  - **3.1.2** 59 West Meadow Road 2.2
- **3.1.3** O Seaver Road –Numerous complaints have been received in regards to wetland violations. There is an approved Forestry Plan for the property which has been completed. DH visited the site and believed that there are some areas of concern that are jurisdictional. Site was walked with the owner, Daniel Gardner. Mr. Gardner told DH that he would be having the area delineated sometime in the near future. Eight test-pits have been dug, three of which may be jurisdictional. A Cease and Desist was sent out on January 8, 2019 requesting that work stop until the area in delineated.
- **3.1.4** Adams Road- Complaint was received from a neighbor regarding work that had been conducted in the resource area. The homeowners were cleaning out a channel to prevent flooding. A Superseding Order of Conditions was issued in 1992 and recorded at the Registry of Deeds. The Conditions require that the channel and culvert be maintained and cleaned out.
- **3.2** Discuss Land Acquisition account wording After drafting limitations for the account and discussing with the accountant, it was decided to leave the MGL language as is so not to create great limitations for the use. Use of the funds will be left up to the discretion of the Conservation Commission.
- **3.3** Approve and sign Certificate of Compliance for 235 Wallace Hill Road DEP#308-521- DH visited the site and would like to see another growing cycle. The property is also in NHESP jurisdiction.
- **3.4** Approve payment to MACC in the amount of \$60.00 for Staff Membership from the Wetland Protection Act Fund.-JL moves to approve payment to MACC. CV seconded. All in favor.
