ARTICLE 1

To see if the Town will vote to raise and appropriate, or transfer from available funds in the treasury, the sum of **\$5,165.20**, or any other sum, for the purpose of paying prior fiscal year bills; or take any other action in relation thereto.

ARTICLE 2

GENERAL BUSINESS, GENERAL BYLAWS AND ADOPTIONS (MAJORITY VOTE)

ARTICLE 8

To see if the Town will vote to accept Massachusetts General Law Chapter 41 Section 19K, to allow the Town Clerk who has completed the necessary courses of study and training, and has been awarded a certificate by the Massachusetts Town Clerks' Association as a Certified Massachusetts Municipal Clerk, to receive as compensation from such town, in addition to the regular annual compensation paid by such town for services in such office, an amount equal to 10 per cent of such regular annual compensation, but not more than \$1,000 per year; or take any other action in relation thereto.

<u>DESCRIPTION</u>: This article "Accepts" MGL to enable the Town to pay the Town Clerk according to the provision of this law. The amount is already in the FY 22 budget that was approved last May.

ARTICLE 9

To see if the Town will vote: (i) to amend Chapter 1 of the Town's General Bylaws, entitled "General Provisions," Article II, entitled "Noncriminal Disposition of Violations," Section 1-1, entitled "Fine schedule and enforcing officers," Subsection D, entitled "Unregistered Motor Vehicles Bylaw," as follows, with additions thereto <u>underlined</u> and deletions therefrom <u>stricken-through</u>:

- D. Unregistered Motor Vehicles Bylaw.
 - (1) Enforcing officers:
 - (a) Townsend Police.
 - (b) Building Inspector.
 - (2) Fine schedule:
 - (1a) First offense: written warning.
 - (2b) Second offense: \$100 per day.

and (ii) to delete from Chapter 112 of the General Bylaws, entitled "Streets and Sidewalks," Section 112-14, entitled "Unregistered motor vehicles," it its entirety, but to relocate and renumber the same as Chapter 128 of the General Bylaws, as follows, with additions to the existing text <u>underlined</u> and deletions from the existing text <u>stricken-through</u>:

§ 112-14 Chapter 128 Unregistered Motor Vehicles

- A. No person or entity shall keep or permit to be kept on any premises within the Town of Townsend more than one unregistered motor vehicle assembled or disassembled unless said vehicles are stored within an enclosed building. The one unregistered motor vehicle shall be no closer than 75 feet to a public way, and no closer than 75 feet to the property line of another than the minimum setback for a new primary building or dwelling, whichever setback is greater, in the applicable zoning district.
- B. For good cause shown, and upon application on a form approved for such purpose and the payment of any applicable fee, the Board of Selectmen may issue a permit to keep more than one unregistered motor vehicle on any premises not within an enclosed building. Issuance of a permit hereunder shall occur only after a duly called public hearing, to of which all abutters to the premises have received a at least five (5) days advance notice, if it finds and only upon a finding by the Board of Selectmen that such keeping:
 - Will not adversely affect the neighborhood;
 - (2) Will not be a nuisance; or and
 - (3) The keeping of such vehicles will not be in conjunction with a use that is:
 - (a) Otherwise not permissible in the zoning district; or
 - (b) Is permissible by a special permit from the Zoning Board of Appeals but no permit has been granted.

- C. All permits granted shall limit the number of unregistered motor vehicles to be kept on the premises by the permit holder, shall not run with the land, and shall be limited to a reasonable length of time to be determined by the Board of Selectmen.
- D. The provision of Subsections Sections A through E F, inclusive, of this section Bylaw-, shall not apply to motor vehicles designed and used for farming purposes, nor to persons or entities in the lawful exercise of licenses granted under MGL c. 140, §§ 58 and 59.
- E. The Police Chief, the Building Inspector or his their respective designees, shall enforce this section Bylaw. No other Town official shall have the authority to enforce the section. No other Town official shall investigate any potential violations. Upon receipt of a written complaint to the Board of Selectmen, the Police Chief, the Building Inspector or his their respective designees, shall perform a site inspection and investigation and shall report his their findings to the Board of Selectmen in writing. The report shall contain the the property address on at which the vehicles(s) is are located, as well as the make, model, year and color of the vehicle(s), if known, and their approximate location on the site. If the report finds that the vehicle(s) is in a violation of this section, the Board of Selectmen shall send a certified letter to the owner of the land, on which said vehicle(s) is parked, and the property owner will have 30 days to remove said vehicle(s).
- F. Whoever violates any provisions of this section of the Townsend General Bylaws shall be liable for a penalty of \$100 per day for each day of violation. Violations will be calculated from the date of the certified mailing. No penalty will be assessed if the vehicle(s) is removed within 30 days and there are no subsequent violations on the same property. This Bylaw may be enforced by the designated enforcing officers and/or by the Board of Selectmen, through any lawful means in law or in equity, including but not limited to noncriminal disposition in accordance with the provisions of MGL c. 40, § 21D and § 1-1 of the Townsend Code, Article II, including the fine schedule incorporated therein. Each violation and each day that such violation occurs or continues to occur shall constitute a separate offense.
