➤ EH researched how other towns handled getting Energy considerations / directions into their Master Plans. Others worked from a set of goals provided to the Departments / Committees so that the selected interest groups can embed supports for Town energy goals into their section of the Master Plan.

The approach seems to have the advantage of having whole committees and Departments rather individuals representing them contribute to the development efforts while taking pressure off of finding com/dept representatives.

Prep for 2023 Spring Block, Green Communities Grant-funded Program:

➤ Asked ref "Special Eligibility" under GCGP: Requires 6 years in "Good Standing" in the GCGP and a minimum of 15% energy reduction over last 3 years.

12/1/2022 Karen Chapman at MRPC provided the following info: "Townsend has a 7.45% reduction in energy usage since the baseline year of FY10, and 6% over the last 3 years, so no I guess Townsend does not qualify for "Special Projects". Townsend has been in good standing for at least 6 years though."

Question asked and answered about status of Squanacook Elementary, previously ineligibile:

TA, Eric Slagle answered 1/3/23: "Squannacook is not used as a school by NMRSD, even though they own it. They use it as an admin building. The Town does not pay energy bills for this building."
