The Special Town Meeting was called to order at 7:06 pm with 235 voters present and 21 visitors signed in to attend the meeting. Moderator, John Barrett, introduced the Town Clerk, Kathleen Spofford, the Board of Selectmen, Charles Sexton-Diranian, Joseph Shank and Theresa Morse as well as Town Administrator, Eric Slagle and Town Counsel, Adam Costa. He also introduced the members of the Finance Committee who were present, Don Hayes, Jerrilyn Bozicas and Sam Grant and our Treasurer, Melissa Dunnet. The Moderator appointed counters and the Town Clerk swore in Rebecca Sturtevant, Brian Funaiole, Wayne Miller, and Rob Templeton. The Moderator reviewed the rules of the town meeting according to Town Meeting Time. The Town Clerk read the service of the warrant. Town Administrator, Eric Slagle, presented information on $2\frac{1}{2}$ overrides.
